This has reference to the RTI received from Mr. Anil K Kataria having reg. no: PGCIL/R/E/20/00176.

Information Sought:

Following information is required w.r.t western region 2 headquarter of POWERGRID situated at Vadodara under the RTI act 2005:

- How many employees in executive cadre are posted in wr2 in various location as on date and since when?
- How many intra region transfers of employees in executive cadre are been done in wr2 since 2015.
- 3. How many intra region transfers of employees in executive cadre has been cancelled in wr2 since 2015, kindly mention the reason of cancellation of transfer order.
- How many employees in executive cadre are been posted on same place irrespective of change in department and assignment for more than last 10 years in wr2.
- 5. How many employees of SC category in executive cadre are there in western region2.
- 6. How many employees of ST category in executive cadre are there in western region 2.
- Kindly provide the list of employees for both SC and ST category location wise posted in western region2.
- 8. Kindly provide the strength of employees of SC. ST, OBC and general category posted in x,y and z classified cities in western region2 with the names of cities.

Reply:

 As on date a total of 300 Employees in Executive Cadre are posted in WRTS-II. Further, other information sought by the applicant are in the form of voluminous data and the preparation of the same would disproportionately divert the resources of the public authority and is therefore avoided under Sec 7 (9) of RTI Act, 2005.

- 2. The data is not readily available and needs to be created thus, cannot be furnished as per Section 2 (f) of the RTI Act, 2005.

- 4. A total of 14 employees have been posted on same location for more than 10 years.
- 5. A total of 43 Employees (Executive Cadre) of SC Category are posted in WRTS-II.
- 6. A total of 13 Employees (Executive Cadre) of ST Category are posted in WRTS-II.
- 7. Total no. of SC & ST employees in WRTS-II is 198. However, names cannot be furnished as per Section 8(1)J of the RTI Act, 2005.
- 8. Strength of Employees (All category & cadre) posted in WRTS-II is as mentioned below.
