




During field survey of DFC alignment between village Gothan and village Abrama of District Surat, it is found that 220 KV double circuit Ichhapur-Vav line infringing proposed Dedicated Freight Corridor alignment at chainage. 24000. GETCO/Vav's officers have informed that this line now renamed as **KAWAS-VAV** line and it is now pertains to Power Grid Corporation.


