

Respected Sir,

As you may be kindly aware that, POWERGRID (Govt. of India Enterprise) is presently executing the Construction of 220kV D/C Navsari (Dastan)-Bhestan/Popada Transmission Lines in Surat District. This line is to be implemented on urgent basis to cater to overloading observed on Vav-Popada/Sachin-Naysari (GETCO)- Navsari (Powergrid) 220 kV" Lines and to avoid line tripping due to overloading etc. The said transmission line is only 18.58 Kms length and 75 Towers.


As per original schedule, this line was to be commissioned by Dec'2020, however, the project is not progressing well due to severe ROW issues in Palsana&Chouryasi Taluka. On date, only 15 tower foundations and 03 tower erection completed against the total qty of 75 towers. The rescheduled target for project completion by March 2021.

Progress of foundation and tower erection works are very slow, as the farmers are demanding for DC order towards land compensation. Earlier as per your guidance, SDM,Kamrej and Mamlatdar,Palsana conducted the inquiry with the concerned farmers on 21.11.2020 and further report also obtained from Dy.Collector/Stamp Duty/Rural/Surat and further recommendations are still awaited.


In the view of above, it is requested to arrange to issue necessary orders to release the land compensation to the affected farmers and to proceed with construction activities in the interest of nation as well as state of Gujarat.
