The date on which the installation of the electrical pole took place. 2. The name of the person/organization responsible for the installation of the pole. 3. The reason for installing the pole on my land without my consent. 4. Whether the Power Grid Corporation of India Ltd. had taken permission from the appropriate authorities before installing the pole. 5. Whether the Power Grid Corporation of India Ltd. had followed the due process before installing the pole. 6. I would also like to know the actions taken by the Power Grid Corporation of India Ltd. to rectify the issue and relocate the electrical pole from my land. <p>Further, I would like to request the following information:</p>	

1. Copies of all documents related to the installation of the electrical pole on my land, including but not limited to the permission obtained, if any, for the installation.
2. Copies of all correspondence, if any, between the Power Grid Corporation of India Ltd. and the landowner regarding the installation of the electrical pole.
3. Copies of any rules, regulations, guidelines, or policies, if any, governing the installation of electrical poles on private property, and their compliance by the Power Grid Corporation of India Ltd.

I would like to receive this information in English and in a format that can be easily understood.

Kindly provide the requested information within the stipulated time frame of 30 days, as per the Right to Information Act, 2005. If the information cannot be provided within the given time frame, please inform me of the reasons for the delay and the expected date of receipt of the information.

Under the Right to Information Act, 2005, I am entitled to receive this information free of cost if the information sought is in the larger public interest. In case of any charges, please inform me of the same and provide me with a receipt of the payment made.

I would like to thank you in advance for your cooperation and look forward to receiving the information at the earliest.
