Subject: Information sought under RTI Act, 2005.

Dear Sir,

This is in reference to your letter dated 26th December, 2014 received in this office on 5th January,2015 seeking information regarding copy of all exchange of messages between WRLDC and Sasan UMPP on operational aspects of Sasan Unit – 5 for the period 22.08.2014 to 26.12.2014.

It is noted that, for the queries 1 to 5 the information is sought for the copy of all messages exchanged between WRLDC and Sasan UMPP relating to the **operation / running / testing / infirm generation / loading etc of Sasan unit no. 5 for the period dt. 22/8/2014 to 26/12/2014** . It is to be mentioned that the information sought for the period for nearly four months is quite voluminous and generic in nature. The extraction and providing the information in the desired form would require disproportionate diversion of resources. As per Section 7(9) of RTI Act 2005,

Quote

“An information shall ordinarily be provided in the form in which it is sought unless it would disproportionately divert the resources of the public authority or would be detrimental to the safety or preservation of the record in question.”

Unquote

However, as per the RTI Act-2005, a citizen has right to inspect the documents and records taking notes and taking certified samples of material held by the public authority or held under the control of the public authority .

Hence you are requested to inspect the above records at our office with prior notice for getting reply of your queries no. 1 to 5 on payment of the fees as applicable.


