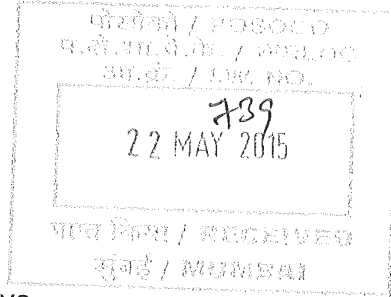



Emoluments offered to candidates selected against reserved posts are same as that offered to those who are selected against unreserved posts.</p> <p>However, the eligibility criteria are relaxed for PwD candidates as mentioned below:</p> <ul style="list-style-type: none"> • Age: Relaxation as per clause 21 of DoPT OM No. 36035/3/2004-Estt.(Res.) dated 29.12.2005 irrespective of reservation for posts for PwD • Marks in essential qualification: Relaxation at par with SC/ST candidates subject to reservation of posts • No. of years of experience: Relaxation at par with SC/ST candidates subject to reservation of posts • Qualifying marks in Written test and Personal Interview: Relaxation at par with SC/ST candidates subject to reservation of posts • Application Fee: Exemption from payment of application fee irrespective of reservation for posts for PwD <p>(b) & (c): Information is not maintained in the requested manner. Group wise information regarding recruitment done at Corporate Center, in particular, name of the candidates and the position at which they are hired is present in the PwD rosters pertaining to different groups. The rosters from 1996 onwards are numerous and voluminous. Addresses of all employees are maintained in their respective personal files.</p> <p>These documents can be inspected at our office on any working day with prior intimation of at least 30 days.</p> <p>As on date, there is only one carried forward vacancy for PwD in Corporate Center and the same is already under process for recruitment for the post of ET(Electrical) - 20th batch.</p> <p>For recruitment done in regions, our respective RHQs may be visited on any working day with prior intimation of at least 30 days.</p> |
